

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to asiasonai.com and AsiaSonai and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to AsiaSonai include asiasonai.com and AsiaSonai. The AsiaSonai website is a Portfolio and information site. By using the AsiaSonai website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, AsiaSonai may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase AsiaSonai's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

AsiaSonai may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

AsiaSonai collects and uses your personal information to operate its website(s) and deliver the services you have requested.

AsiaSonai may also use your personally identifiable information to inform you of other products or services available from AsiaSonai and its affiliates.

Sharing Information with Third Parties

AsiaSonai does not sell, rent or lease its customer lists to third parties.

AsiaSonai may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is transferred to the third party. AsiaSonai may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to AsiaSonai, and they are required to maintain the confidentiality of your information.

Tracking User Behavior

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by AsiaSonai. Use of Cookies

The AsiaSonai website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

Children Under Thirteen
